SESSION CONTRACT

11. This agreement constitutes an order for your hair/makeup services, including the taking of portrait photos as agreed to both parties: ***Bridal Hair and Makeup by Edie*** and contacting party(client). Unless otherwise specified, it is understood that any and all photographs may be used for advertising, display or any other purpose thought proper by ***Bridal Hair and Makeup by Edie***.
12. If ***Bridal Hair and Makeup by Edie***, cannot perform this agreement in whole or in part due to a fire, or other casualty, acts of God or nature or terror or other cause beyond the control of the parties due to the artist's illness or injury, then ***Bridal Hair and Makeup by Edie*** will return all fees to the client(s) but shall have no further liability with respect to the this agreement.
13. In the event of an extenuating circumstance on ***Bridal Hair and Makeup by Edie's*** part, ***Bridal Hair and Makeup by Edie*** will find and hire an alternative stylist/artist's or reimburse the full amount paid to the customer, including the deposit or will re-schedule for a different time. ***Bridal Hair and Makeup by Edie*** will not be held liable for services not rendered. To receive refund, ***Bridal Hair and Makeup by Edie*** must have a 2-week notice from the schedule session.
14. On signing of this agreement by both parties hereto, ***Bridal Hair and Makeup by Edie*** will reserve the time agreed upon and will not make another reservation for the specific time frame.
15. ***Bridal Hair and Makeup by Edie*** is the only stylist/artist's to perform the cosmetic and/or hair services requested on this contract. No other hair and/or makeup artist is allowed to apply makeup or do hair at the time of the session, unless collaboration has been pre approved by BHME.
16. The amount agreed upon covers ***Bridal Hair and Makeup by Edie's*** time and talent. It also cannot be changed or altered by any means.
17. A non refundable retainer of (50% of quote) is due at the time of consultation appointment. This non-refundable retainer applies to bridal parties. This guarantees the time & date allotted for you. Should payment not be received in this time frame, ***Bridal Hair and Makeup by Edie*** reserves the right to offer the date & time to another client.

18. ***Bridal Hair and Makeup by Edie*** price list is adjusted periodically and future orders will be charged at current pricing of that time.
19. ***Bridal Hair and Makeup by Edie*** shall be printed in any publication of the photographs. The client shall use their best endeavors to ensure that ***Bridal Hair and Makeup by Edie*** is given full acknowledgment in any edition of the work sub-licensed by the client to a third party.
20. Client agrees to notify ***Bridal Hair and Makeup by Edie*** of any allergies he/she may have toward any cosmetics or chemicals. Should a reaction occur, requiring medical attention or not, it is agreed that ***Bridal Hair and Makeup by Edie*** not legally liable or responsible for any injury and/or ailment of any kind.
21. Cancellations must be made 1 month (30 days) prior to your reserved date or you will be responsible for the amount of services agreed in this contract.
22. There is no travel fee for the first 10 miles outside of Burleson, TX. Each additional 10 miles after that will be \$7.00 per 10 miles. Parking fees/tolls must be paid by client.

Contagious Disease Bridal & Makeup by Edie has the right to refuse services to anyone that may have open wounds, pink eye, sores, flu, or any other type of contagious illness or disease without refund.

Travel Fee: There is no travel fee for the first 10 miles from Buleson, TX. Travel fees will be determined based on distance at the time of Booking. Parking fees or tolls must be paid by client. Towing charges will be Paid by the Client so please be sure your information about parking is correct to prevent such a circumstance.

Under the Weather: (In regards to: Trial Run, Engagement Photos, Bridal's or Boudoirs) If you are feeling ill, please call to reschedule, Bridal Hair & Makeup by Edie understands that sometimes, this happens. If you must cancel, please try to do so at least 24 hours prior to your session.

Payment Options: Bridal Hair & Makeup by Edie accepts cash if agreed upon however we prefer debit/credit card. All card payments come with a small transaction fee of \$3.00. Only Local Checks If agreed upon are to be made payable to Edie M Cooper.
